## DAYCO CANADA EARN A DREAM VACATION PROMOTION Official Rules

### Promotion Period

1. The **Dayco Canada EARN A DREAM VACATION Promotion** (the "**Promotion**") begins at 8:00 a.m. Eastern Daylight Time ("**EDT**") on Sunday, March 1, 2020 and ends at 5:00 p.m. EDT on Monday, August 31, 2020 (the "**Promotion Period**"). The Promotion is being conducted by Dayco Canada Corp. ("**Sponsor**").

### How to Enter

2. All businesses that buy directly from Dayco Canada Corp. (**Dayco Jobber**) either new or existing must complete a registration form to declare their intention to participate in the promotion. ### Eligibility

3. The Promotion is eligible for all Dayco Jobbers who register prior to the end of the promotion period. Dayco Jobbers will fall into 1 of 2 categories and eligibility will be dependent on these conditions. (a) New or inactive Dayco Jobber with no sales from March 1 – August 31, 2019; (b) Existing or active Dayco Jobber with sales from in 2019;
  - a) New Dayco Jobbers who have completed a registration form will earn a Prize with cumulative net sales of \$50,000.00 or more during the promotion period. Jobber must have a minimum sales volume of \$50,000.00 during the promotion period to participate.

Jobber must have a minimum sales volume of \$50,000.00 over their previous year during the promotion period to participate.

## Prize
